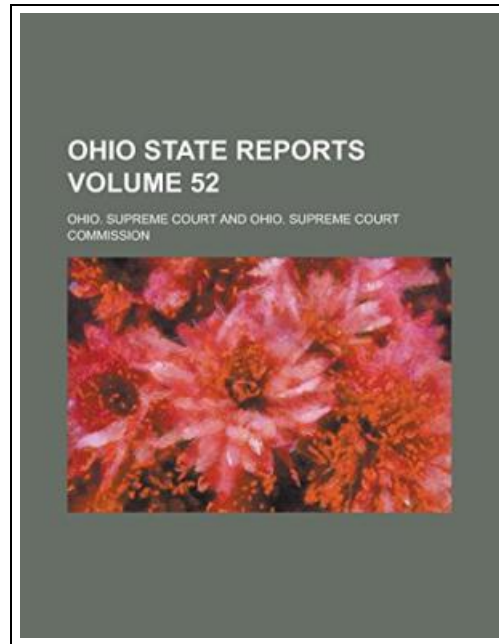

The original action was begun in the Superior Court of Cincinnati by Henry Batsche, one of the defendants in error, on behalf of himself and other persons named in his petition, to wit: Margaret Wilmer, The Walton Architectural Iron Company, The American Cotton Oil Company, Cliflord Perin, Johanna Kirkpatrick, The Queen City Spring Company, Charles Harkness, F. A. Sudbeck heirs, and H. W. Schorfheide, to enjoin the collection of a special assessment levied by the city of Cincinnati, one of the plaintiffs in error, on their property abutting on Culvert street, between Fifth and Sixth streets, in said city, to pay the cost of condemning property to widen and open Culvert street to its full width between said points. Prior to July 22, 1887, Culvert street, between Fifth and Sixth streets, was partly opened to the Cincinnati 2/.
